
Installation

To install the SoundStation IP 7000, plug one end of the network cable into the network port on the bottom of the SoundStation IP 7000 console, and plug the other end of the network cable into your data port with PoE.





External Microphone

After it has been connected to the network, the SoundStation IP 7000 automatically powers up via Power over Ethernet (PoE), and begins a process of establishing itself on the network. When this is complete, the Idle screen is displayed (as shown on the right).

Warranty, Copyright, Safety Notices

LIMITED WARRANTY. Polycom warrants to the end user ("Customer") that this product will be free from defects in workmanship and materials, under normal use and service, for one year from the date of purchase from Polycom or its authorized reseller. Responsibility for loss or damage does not transfer to Polycom until the returned item is received by Polycom. The repaired or replaced item will be shipped to Customer, at Polycom's expense, not later than thirty (30) days after Polycom receives the defective product, and Polycom will retain risk of loss or damage until the item is delivered to Customer.

EXCLUSIONS. Polycom will not be liable under this limited warranty if its testing and examination disclose that the alleged defect or malfunction in the product does not exist or results from:

- Failure to follow Polycom's installation, operation, or maintenance instructions.
- Unauthorized product modification or alteration.
