

End User License, Warranty, and Safety Notices

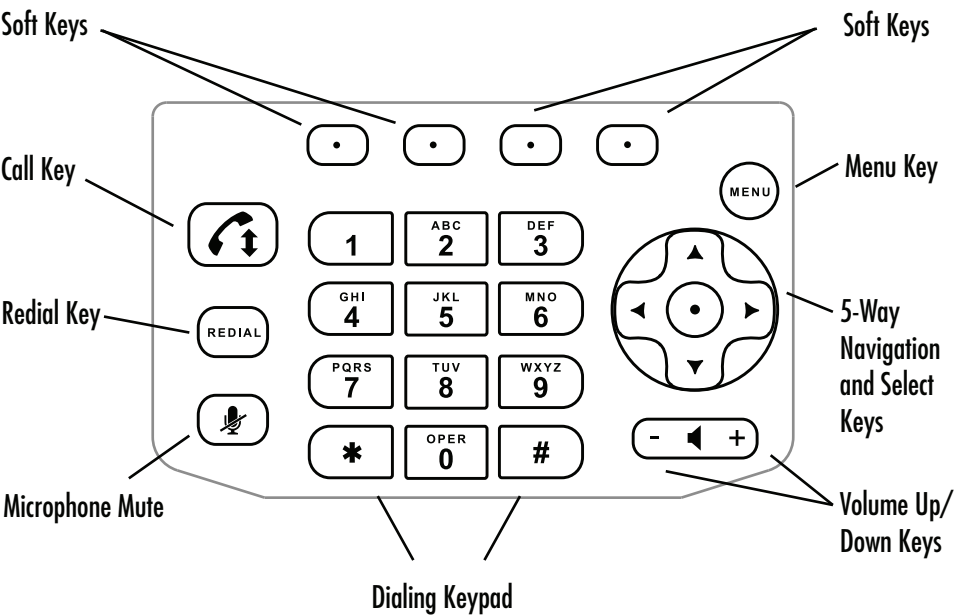
Startup
